Accomplished via improved security and system configuration standards, improving auditing trails and controls, implementing additional security systems and independent security reviews.
- **Managed the implementation of multiple new mission critical services**, including two new data processing services and a new item processing service. Coordinated project management, overseas development, and implementation teams alongside the sales and customer service groups to insure proper SDLC practice and successful implementations.
- **Conceived and developed multiple new products**, including DirectorAccess, Managed Security Services and BankMail which added revenue generation to a department that had previously been solely a cost-center.
- **Built a secondary datacenter in southern New Jersey** to improve access to the Philadelphia Federal Reserve office and improve disaster recovery capabilities.
- **Improved disaster recovery time to recovery (RTO) and data point recovery (RPO)** through the use of replicated systems. Utilized secondary site to replicate backup images, improving security and improving reliability by elimination of tapes. Followed up with near real-time replication of databases.
- **Responsible for multiple initiatives to reduce costs and improve reliability.** Initiatives included: Standardizing hardware and software to reduce maintenance needs on servers and desktops. Implemented server virtualization to improve system reliability, reduce build times and cut costs, increasing server to technician ratio over 4-fold.
